

## CONNEXALL WORLDCONNEX 2024 GLOBAL CONFERENCE

### PARTICIPANT TERMS & CONDITIONS

Thank you for registering for the Connexall WorldConnex 2024 Global Conference (“**WorldConnex**”). The following Terms and Conditions (“**T&C**”) apply to you and your registration, participation, and attendance in WorldConnex. Your registration may include in-person programming (including general admission keynotes, general education sessions, opening reception and exhibition). “**Attendee**” means all participants at WorldConnex including exhibitors, sponsors, speakers, press, partners, and individual attendees. By attending WorldConnex, you agree to these T&C, so please read them carefully.

WorldConnex is organized by Connexall USA, Inc. (“**Connexall**”), which reserves the right, in its sole discretion, to limit or deny access to any entity or individual. To be eligible to participate, you must be 21 years old or older.

#### **Registration & Fee**

Organizations (including but not limited to hospitals and health systems) that maintain one or more agreements with Connexall for Service and Maintenance (SMA) that explicitly states that they are eligible to receive complimentary admission to WorldConnex are eligible to redeem one complimentary admission pass to WorldConnex. Otherwise, the regular admission rates on the WorldConnex registration page apply.

Admission covers access to all sessions, speakers, and panel discussions as well as lodging accommodations and meals during conference events. Airfare, transportation, hotel incidentals, meals, upgrades, services, and any activities outside of scheduled conference events are not included.

#### **Attendee Cancellation Policy**

If circumstances change and you can no longer attend this Conference, the cancellation policy outlined below applies. To cancel, send an email to [worldconnex@connexall.com](mailto:worldconnex@connexall.com). Connexall may incur significant costs and fees in the event a confirmed Attendee does not attend WorldConnex. Cancellations prior to the **cut-off date of September 20, 2024** (“**Cut-Off Date**”) will be eligible for a refund of the registration fee. Due to costs borne by Connexall for cancellations: (a) cancellations on or after

the Cut-Off Date, regardless of the reason for cancellation, including, but not limited to failure to attend the conference because of illness, travel problems, natural disaster or weather emergency, civil unrest, epidemic, public health emergency (declared or undeclared), or an act of terrorism, will not be eligible for a refund of the registration fee; and (b) Attendees with complementary registration must pay a cancellation fee of \$950.

#### **Governing Law, Venue, Class Action Waiver, & Jury Waiver**

You agree that any disputes related to your registration, participation, and attendance at WorldConnex shall be governed exclusively by the substantive laws of the State of Illinois without giving effect to any conflict of laws principles. You further agree that the mandatory, exclusive venue for any action related to your participation in and/or fees paid for WorldConnex shall be the federal court of the Northern District of Illinois or any state court in the State of Illinois, Cook County. You further agree that any action brought in these courts related in any way to WorldConnex, will be an individual claim, that you shall not bring claims against Connexall in a representative capacity on behalf of any other individual, that you shall opt out of any class proceeding, and that you shall not assert class or collection action procedures. You further agree that both you and Connexall waive any right to a trial by jury for any legal action related to WorldConnex.
